



Speaking Agreement

This Speaker Agreement dated October 25, 2011 (“Agreement”) between the person indicated below (“Speaker”) and IDG World Expo Corp. (“IDG”) is entered into as of the later of the two (2) signatures dates written below, for Macworld | iWorld scheduled for January 26-28, in San Francisco, CA (“Macworld | iWorld”) only.

The parties agree to the following for Macworld | iWorld:

1. IDG World Expo shall be responsible for providing the following:
 - Participation in at least one session slot at Macworld | iWorld; final schedule to be sent separate from this Agreement.
 - High Quality Audio/Visual sound and lighting equipment (A/V).
 - Speaker Office and Green Room for speaker to access.
2. The speaker shall be responsible for providing the following: (check) ___
 - Present an original topic, that is not repurposed content from a course taught at another event.
 - Not speak at any other Mac-related conference 45 days prior to Macworld | iWorld, during Macworld | iWorld or for 45 days post Macworld | iWorld.

3. Travel Expenses (check) ___
The Speaker understands that he/she is responsible for his/her own hotel and travel arrangements. The Speaker may take advantage of the special airfare and hotel rates negotiated by IDG for the event by visiting the event Web site.

4. No Commercialism Policy (check) ___
The Speaker agrees to adhere to IDG’s no commercialism policy. The Speaker understands that the conference program is not the appropriate place for promotion of his/her company, product, service, or solution except where such a reference is relevant in the content of the presentation (a user story for instance). It is understood that this type of commercial promotion reflects negatively on the Speaker, his/her company, and the event and is not welcomed by the audience.

5. Consent to Publish Reference Material (check one) ___ Yes ___ No
[If checked “Yes”] The Speaker hereby consents that IDG may publish the reference material in any form (print, electronic, etc.) relating to IDG events from the date of receipt of the reference material until the termination of this Agreement.

6. Authorization to Record Session (check) ___
The Speaker hereby authorizes IDG to record, duplicate, and offer in any form, whether free or for sale, via any media either here known or hereafter devised, the Speaker’s speech/presentation and any portion of the Speaker’s participation in the event. The Speaker hereby waives any and all rights and claims resulting from recording, duplicating, or distribution.

7. Indemnification (check) ___
The Speaker warrants that all authors are properly credited in the handout and the Speaker has the right to make the grants made to IDG complete and unencumbered. The Speaker also warrants and represents that none of the material presented in the Speaker’s speech/presentation shall infringe any person or entity’s copyright, invade any right of privacy, contain any libelous material, or infringe or violate any other right of any other person or entity. The Speaker will indemnify and hold harmless IDG, its employees, officers, directors, agents, representatives, parent, affiliates, or subsidiary companies from any claim, suit, damage, loss, or expense (including reasonable attorneys’ fees) arising out of any breach of any allegation which if true would constitute a breach of any of the above warranties and representations.

8. Unless otherwise expressly provided herein, all terms and conditions of the Agreement shall remain in full force and effect.
